Scope Notes and Usage Guide

This subject index contains listings for every notable subject mentioned in the Blue Ridge Lambda Alliance newsletter and its later name, the Blue Ridge Lambda Press. Currently, the guide contains listings for all issues published from the newsletter's start in 1981 through the end of 1995, with later issues to be added in the near future.

The guide is divided into sections for **Organizations, Publications, Places, Public Figures, Public Events,** and relevant **Legislation and Court Cases.** All listings are organized alphabetically, and then presented with the acronym for their publication (BRLA for the Lambda Alliance newsletter, BRLP for the Lambda Press), followed by the corresponding volume, issue number within the volume, and a page number, and corresponding issues are linked directly for ease of access. The listings are presented in chronological order, with the oldest being listed first.

Because the BRLA/BRLP were the newsletter of the **Blue Ridge Lambda Alliance**, this group has not received its own heading, as it can be reasonably assumed that for all the issues where this was the case, the group was mentioned. The same can be said for its headquarters, 314 Harrison St. in Lynchburg, as many of the group's events were held there. Similarly, to avoid potential redundancy, listings in the **Organizations** and **Places** headings are registered the first time that they appear and also when they detail specific events or initiatives, but advertisements or listings in directories with no further information have been omitted. Starting in 1986, the BRLP began being published instead by the **Roanoke Valley Gay Alliance**, which changed its name to the **Roanoke Valley Gay and Lesbian Alliance** in 1992.
